Amendment of the Special Provisions for the “International Management” master’s programme, published in the Official Notices of the Hochschule RheinMain no. 387 of 1st March 2016

Based on art. 44 sub-section 1 no. 1 of the Higher Education Act of Hesse (HHG) in the version of 14th December 2009 (Official Gazette I p. 666), last amended by article 1 of the law of 30th November 2015 (Official Gazette, p. 510), the faculty council of the faculty of Wiesbaden Business School at the Hochschule RheinMain adopted the following amendments to the above mentioned examination regulations on 8th November 2016. These amendments correspond to the general provisions for examination regulations for master’s programmes (ABPO-Master) of the Hochschule RheinMain of 16th April 2013, published in the Official Notices no. 223 of 16th April 2013 and were adopted at the 144th meeting of the senate of the Hochschule RheinMain on 15th November 2016 and approved by the steering committee on 15th November 2016 in accordance with art. 37 para. 5 HHG.

The amendment is indicated in bold print, in italics and by underlining.

I. Amendments

Section 1(1) is changed as follows:

“This is a consecutive course of studies. Admission requirements are established in the statutes regarding admission to the master’s programmes in International Management (M.A.), Controlling and Finance (M.A.), Sales and Marketing Management (M.A.), Business & Law in Accounting and Taxation (LL.M.), Insurance and Finance (M.Sc.), Management in Healthcare (M.A.) in the respectively valid version.”

is replaced by:

“This is a consecutive course of studies. Admission requirements are defined in the statutes regarding admission to the “International Management” master’s programme in the respectively valid version.”

Section 1 (2) is changed as follows:

“For more details see the statutes regarding admission to the master’s programmes in International Management (M.A.), Controlling and Finance (M.A.), Sales and Marketing Management (M.A.), Business & Law in Accounting and Taxation (LL.M.), Insurance and Finance (M.Sc.), Management in Healthcare (M.A.).”

is replaced by:

“For more details see the statutes regarding admission to the “International Management” master’s programme in the respectively valid version.”

Section 1(3) is changed as follows:

“Special professional requirements are established in the statutes regarding admission to the master’s programmes in International Management (M.A.), Controlling and Finance (M.A.), Sales and Marketing Management (M.A.), Business & Law in Accounting and Taxation (LL.M.), Insurance and Finance (M.Sc.), Management in Healthcare (M.A.).”

is replaced by:

“For more details see the statutes regarding admission to the “International Management” master’s programme in the respectively valid version.”

Section 1 (5) is changed as follows:

“Proof of sufficient command of the German language is not required, since the course of studies is taught in English.”

is replaced by:

“For more details see the statutes regarding admission to the “International Management” master’s programme in the respectively valid version.”

Section 1 (6) is changed as follows:

“Selection procedures are established in the statutes regarding admission to the master’s programmes in International Management (M.A.), Controlling and Finance (M.A.), Sales and Marketing Management (M.A.), Business & Law in Accounting and Taxation (LL.M.), Insurance and Finance (M.Sc.), Management in Healthcare (M.A.).”

is replaced by:

“For more details see the statutes regarding admission to the “International Management” master’s programme in the respectively valid version.”

II. Entry into force

These amendments of the examination regulations enter into force upon their publication in the Official Notices of the Hochschule RheinMain as of 15th November 2016 and are effective for enrolments for the 2017 summer term for the first time.
