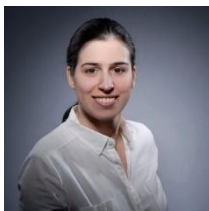
Heidrun Schulze

Her scholarship and teaching focus on methodology and methods of interpretative social research, biographical research, children's rights-based research, conversation analytic research on counseling, psychosocial traumatology, gender-specific and generation-specific violence, and narrative counseling and therapy. Her article "Application Potential of Conversation Analytic Research for Counseling and Consultancy Practices Based on Children's Rights (Qualitative Social Work, in press) is based on her recent research project titled Participation and Empowerment of Children in the Counseling Process (short form: BeKinBera, www.bekinbera.de). She is co-editor of the forthcoming book **Power, Ethics, Diversity and Counseling*. Together with GIZ Peru/Ecuador she also wrote a handbook an international prevention project for deconstructing gender-based and generation-based stereotypes which lead to violent behavior. Currently, she qualifies students to carry out this project at schools in Germany.



James I. Martin

PhD, is Associate Professor at the NYU Silver School of Social Work, where he also serves as Associate Dean for Academic Affairs and Director of the MSW Program. At NYU he has taught social work practice and research methods as well as LGBT issues. His scholarship focuses on the development and construction of LGBT identities, and health and mental health disparities among LGBT populations. Dr. Martin is co-editor of the *Handbook of Research on Lesbian, Gay, Bisexual and Transgender Populations* (Routledge, 2009) and author of numerous peer-reviewed articles and book chapters. He has been actively involved in LGBT issues throughout his social work practice and academic career. He is a past co-chair of the Commission on Sexual Orientation and Gender Expression (Council on Social Work Education) and member of the National Committee on LGBT Issues (National Association of Social Workers). He is also a founder and current co-chair of the Caucus of LGBT Faculty and Students in Social Work, a networking and advocacy organization for social work educators and scholars throughout the world.

Rita Nunes, is a Researcher at the Constitutional and Administrative Law Department at Freie Universität Berlin. Rita is also the Coordinator of the Children's Rights European Academic Network (CREAN/ ENMCR). Recently she has been working as a consultant for the German Institute for Human Rights "minimum age requirements in respect to the rights of the child in Germany" and on "Complaint Mechanisms for Children in Germany". Since 2011 Rita Nunes is the editor of the CRnews Newsletter financed by Save the Children Sweden.

Laura Lundy

Professor Laura Lundy is Professor of Education Law and Children's Rights and the Director of the Centre for Children's Rights at Queen's University, Belfast, Northern Ireland (www.qub.ac.uk/ccr.) Her expertise is in law and children's rights, with a particular focus on children's education rights and right to participate in decision-making. Her 2007 paper conceptualizing Article 12 of the UNCRC is one of the most highly cited academic papers on children's rights and the model of participation it proposes (based on four key concepts: Space, Voice, Audience and Influence) has been used globally by policy makers and practitioners. She has extensive practical experience of rights-based, participatory research and consultation with children of all ages and has provide training and consultancy to a range of international organisations including the Committee on the Rights of the Child, the Council of Europe and Child Rights Connect.
